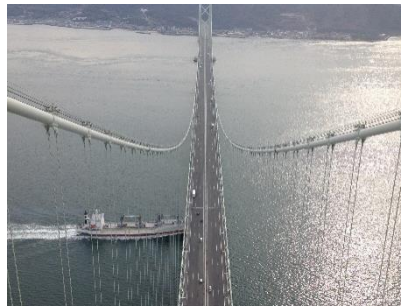

Founded in June 1897, Kyoto University has a long history and enduring traditions. The main campus is located in the historic city of Kyoto, a center of traditional Japanese culture. Since its founding, the university has been dedicated to furthering higher education and fostering an atmosphere of free academic exchange. Graduates of the university play important roles in both national and international affairs, as key players in politics, industry, and society. At present, Kyoto University comprises 10 faculties, 18 graduate schools, 13 research institutes, and 23 educational institutes and other establishments. Approximately 2,700 of the university's 23,200 students hail from overseas. With students from over 120 different countries and regions, the university's campuses boast a rich cultural diversity.

## I Outline of the Undergraduate International Course Program of Civil Engineering

An international course in the Undergraduate School of Civil, Environmental and Resources Engineering has been offered since April 2011. The course focuses on civil engineering for which all classes are provided in English. The course aims to cultivate human resources capable of designing and managing civil infrastructures while considering global environmental issues around urban and regional areas, particularly in Asian and African countries.

This course is a 4-year program leading to a Bachelor of Engineering degree. In the first and second years, students are required to take classes in fundamental mathematics and physics as well as liberal arts. Scientific English and basic Japanese classes are also available. From the second year, specialized civil engineering classes begin, including classes in environmental engineering, earth resources and energy science. For the first three years, all classes will be offered at Yoshida Campus, the main campus of Kyoto University. In the fourth (final) year, students with sufficient credits will be able to join a research group and may relocate to one of the university's other nearby campuses, such as Katsura Campus or Uji Campus. Many of Kyoto University's civil engineering related laboratories moved from the main campus to Katsura Campus in 2006. The campus is renowned for its excellent research environment and experiment facilities. Each student will undertake research for their bachelor thesis at his/her designated laboratory. The thesis must be presented and examined in February of the final year, in order to graduate in March.

Kyoto University's many international partnerships with institutions overseas provide students with opportunities to undertake study and research not only in Japan, but also in other countries. A credit transfer system will be made available for students who wish to study outside of Japan for a certain period.

After completing this course, it is recommended that students continue their research in a master's program and some choose to further continue to a doctoral program. Postgraduate programs providing further education and research opportunities in English are available in the Graduate School of Engineering, such as master's programs in the Management of Civil Infrastructure, and Urban and Regional Development in addition to a doctoral program in Human Security Engineering.

## II Enrollment Capacity

A maximum of 30 students can enroll into the International Course Program (hereafter referred to as "ICP") who directly apply to this course according to the admission process outlined in the following. Some additional students may enter the international course program who have successfully passed the regular Kyoto University entrance exam for the Undergraduate School of Civil, Environmental and Resources Engineering and who have sufficient English skills.

### III Eligibility Requirements for Applicants

updated on 21 ,March 2025

Applicants for the ICP admission must satisfy both of the following requirements:

(1)	<p>Must fall under either of the following two categories*:</p> <p>a) Those who are Non-Japanese citizens must have obtained “Student” status of residence at the time of enrollment. [category-1]</p> <p>b) Those who have Japanese citizenship, including dual citizenship, and Non-Japanese citizen who have a status of residence other than “Student” in Japan at the time of enrollment. [category-2]</p>
(2)	<p>Must fulfill at least one of the following four conditions**:</p> <p>a) Have completed or be expected to complete at least 12 years of primary to secondary education in a country other than Japan by March 31, 2026. \* Applicants who fall under [category-2] at the time of enrollment will not be eligible for scholarships intended for “International students”.

\*\*Applicants who have graduated/will graduate from a high school or secondary education school in the Japanese education system are not eligible to apply. Those who have /had received a certain part of their education in the Japanese education system during primary or secondary school may be regarded as ineligible for application depending on the length. Instead, they are encouraged to take the “Common Test for University Admissions/General Admissions” and consider choosing this program.

Once the applicants' eligibility is confirmed, they must submit the official scores of the designated standardized tests and English proficiency tests by the end of the application period. Therefore, those who are judged to be unlikely to be able to submit the scores by the application deadline will not be able to apply, even if they meet the eligibility requirements.

Eligibility will be verified by the admission committees during the preliminary screening. The office does not respond to individual eligibility inquiries via email or phone.

## V Application fee

Once you receive the notification of your eligibility for application, please proceed with the payment procedure for the Application fee (**17,000 yen**). It can be paid by way of the following two options:

### [By credit card]

VISA, Master Card, JCB, AMEX or Diners Club is acceptable. A processing fee of 650 yen will be charged. It is possible to use a card with a name that is different from that of the applicant (e.g. examinee's parents). As for the email address, it must be the same address that you enter into the Online Application System. Please access the following website and follow the instructions.

The "Payment Certificate" PDF must be printed out and uploaded as one of the application documents.

Please make a payment via foreign remittance in yen to the account as detailed below. The original receipt of foreign remittance issued by your local remitting bank or other form of evidence must be uploaded on the Online Application System. **You may be required to pay bank charges to your local remitting bank**, depending on the arrangements for international money transfer in yen via your banking system. Consult with your bank to ensure that the amount to be credited to the Sumitomo Mitsui Bank account detailed below **does not fall short of 17,000 yen**.

## **VI Application Documents**

All documents must be received by the Admission Office during the application period. Applications, including the submission of the required documents, must be made via the Online Application System **by no later than 17:00 (JST) on September 8, 2025.**

Some of the documents may be uploaded by the relevant school.

If it is necessary for a school to upload an application document such as official transcript, the applicant must send a request to them via the Online Application System. It is the applicant's responsibility to make the necessary arrangements to ensure that all required documents and information are uploaded to the Online Application System during the application period specified above. It is not necessary for schools to create an account to log into the system. For details of how to send a request for the upload of documents, please refer to the "User Manual" of the Online Application System.

After uploading the documents and other information, please be sure to click the "Complete" button otherwise your application will not be received. Late or incomplete applications will not be considered.

In addition to the above, applicants who pass the second screening will be required to send original copies of the designated application documents to the Admission Office via registered mail before the payment of the admission fee in December.

If unforeseen, exceptional circumstances such as natural disasters or the political situation in the applicant's country do prevent the timely submission of a document, please contact the admission office in time.

Documents to be uploaded for the Preliminary Eligibility Screening.(August 4-18)	
(1) Digital ID Photo	A digital photograph of the applicant taken within the last three months. The photo must be taken with no hat or head covering, unless there are religious or medical reasons for such. The photo image must not be altered, amended or enhanced.
(2) Copy of Passport	Copied page(s) must include the applicant's name and photograph, the passport number, place of issue, and expiry date. If the applicant does not have a passport, a copy of their official photo ID and its <b><u>English translation</u></b> are also acceptable. (An English translation prepared by the applicant is acceptable.)
(3) Transcript of Academic Record	The Transcript of Academic Record should cover the applicant's entire secondary school (high school, from the 1 <sup>st</sup> year till graduation) or higher education (if applicable) and be issued by the head of the school to which the applicant currently belongs, and/or from which he/she has most recently graduated. If the transcript of the academic record is not in English, both the original and its <b><u>English translation</u></b> must be submitted. (The translation may be prepared by the applicant.)
(4) Form A or A copy of the original Certificate of Graduation.	Form A must be completed by the secondary school (high school) from which the applicant has graduated. If the applicant's school does not agree to use the Form A, the school's own format will be accepted if it contains the same information as Form A.  <u>For the applicant who has graduated</u> from high school by the time of application must submit documents below. <ul style="list-style-type: none"> <li>• Form A <b>or</b> a copy of the Certificate of Graduation with English translation. (6) Form C Financial Plan for undergraduate study	Form C: Describe within 300 words how you intend to cover the required expenses (tuition fees, living expenses) during the four years it normally requires to complete the International Course Program.
(7) Score of English proficiency test result.	<p><b>[English Proficiency Test]</b> Only TOEFL ibt or IELTS academic modules are acceptable. Applicants must take one of these tests by mid-August at the latest so the admission office can verify the official scores online by the end of the application period.</p> <p>*English score exemption* Applicants who will/have spent at least five years at school(s) where all lectures and classes (except for language classes) were conducted in English to complete their secondary education may submit Form D instead of an English proficiency test result.</p> <p><b><u>TOEFL</u></b> <u>A copy of Test Taker Score Report, which ETS sends directly to the applicant's home address, or which is downloadable from the website of ETS, must be uploaded.</u> Applicants are also required to make a request to the ETS for sending an Institutional Score Report to Kyoto University no later than September 8, 2025. The paper version is not needed. The institution code number for Kyoto University is <b>9501</b>. There are no specific code numbers for faculties. The score of TOEFL-iBT (Internet-Based Test) is acceptable. The score of TOEFL-iBT Special Home Edition is also acceptable. <i>MyBest™</i> scores are not acceptable. <b>The minimum requirement is 70 for the iBT.</b> The score is valid only if the examination date is after August 1, 2023. <b><u>Results of TOEFL ITP (Institutional Testing Program) will not be accepted.</u></b></p> <p><b><u>IELTS (Academic Module)</u></b> A copy of the Test Report Form must be uploaded. <b>The minimum requirement is 6.0 for the IELTS Overall Band Score.</b> The score is valid only if the examination date is after August 1, 2023. The score of the IELTS Indicator is NOT acceptable.</p>
(8) Copy of “Score Report” for EJU*	A copy of the Score Report for the EJU (Examination for Japanese University Admission for International Students), must be uploaded. The required examination subjects are <b>Mathematics (Course 2), Physics and Chemistry</b> . Kyoto University will be notified directly of the score results from JASSO as well - examinees will be identifiable by their examinee registration number shown on the copy of the Score Report for the EJU. EJU scores are valid only if the examination date is after August 1, 2023 (such as the 2 <sup>nd</sup> EJU which took place in November, 2023).

**\* If the applicant cannot take the EJU, they must submit one of the following scores instead.**

<p>(8) Score of the International Tests, International Qualifications and others which can be accepted instead of the EJU.</p> <p>* Some of the tests do not cover all the topics that the EJU covers. Therefore, students who can manage to take the EJU test are highly recommended to take this test. Even if another test is taken, please ensure that the topics covered by the EJU are well reviewed and studied in advance of the second screening and university enrollment.</p> <p><u>*The predicted scores issued by the secondary school are not acceptable.</u></p>	<p><b>ACT</b> (American College Test), <b>GCE-A level, International A-level, IB</b> (International Baccalaureate), <b>AP test, GaoKao, CBSE</b> (Class XII) have been accepted instead of EJU.</p> <p>*Final scores must be submitted for <b>Mathematics</b> (for science courses), <b>Physics</b> and <b>Chemistry</b>. Also, downloaded or screenshotted My ACT page which includes your name, scores and ACT ID is required to be uploaded as an application document.</p> <p><b>GCE-A level / International A-level</b></p> <p>The score of Mathematics, Physics and Chemistry is required. Cambridge International A-level and Pearson Edexcel International A-level are acceptable. The copy of the results should be with validation stamp by the secondary educational institution or relevant government authority, etc. and its <b><u>English translation</u></b> must be submitted, if the score record is not written in English.</p> <p><u>*The predicted scores are not acceptable.</u></p>

	<p><b>IB scores</b></p> <p>Math and Physics must be High Level. ## VII Selection Method and Announcement of Results

The selection procedure will be in two parts. The first screening stage will involve an examination of the submitted documents, which are the candidate's scores in English, Mathematics, Physics and Chemistry.

If only General Science is provided in the candidate's national standard test, and Physics and Chemistry cannot be selected individually as is the case with the Chinese national standard test, the score of General Science containing questions in physics and chemistry will also be accepted.

The result of the first screening will be notified to each applicant in early October, 2025. Applicants who do not pass the first screening will be refunded part of their application fee on their request.

For applicants who pass the first screening, a second screening will be carried out. This second stage will be an evaluation of the applicant's aptitude based on the essay (see **V Application Documents (5)**) and basic knowledge of mathematics and physics via an online interview.

As the Admission Office will be in contact by E-mail to arrange this interview, it is the applicant's responsibility to check their mailbox during this time.

The examination results will be announced via the Online Application System on **November 11, 2025**.

Any inquiries relating to the examination results will not be accepted.

However, all applicants must have an active E-mail address to enable quick communication during the admission process.

## VIII Enrollment Procedures for Successful Applicants

### (1) Admission and tuition fees

Admission fee: 282,000 yen (tentative)

Tuition fee: 267,900 yen for Spring Semester (535,800 yen per academic year) (tentative)

#### Note:

- The amounts quoted above are tentative and may be revised at the time of enrollment.
  - The admission fee must be paid **by December 5, 2025** to obtain the Acceptance Letter for Admission, which is essential for visa application.
  - Applicants may apply for the deferred payment of the admission fee if necessary.
  - Exemption or deferred payment of the tuition fee may be granted in certain circumstances. Successful candidates can apply for exemption or deferred payment of the tuition fees after enrollment. In some cases, students who experience financial difficulties may be eligible for a full or half tuition waiver (based on their academic performance).
- (2) Details of enrollment procedures, for example documents to be submitted, method of payment of the admission fee and so on, will be provided to the successful applicants with the notification of examination results.
- (3) Successful applicants are asked to inform the office immediately if they decide not to enroll.
- (4) Successful applicants must be able to provide for their admission and tuition fees and living expenses in Japan.

## IX Scholarships, Accommodation and Life in Kyoto

### ● ICP Scholarship

The university and the alumni association of civil engineering related departments provide scholarships for students who have superior grades.

### ● MEXT Scholarship [university recommendation]

Kyoto University will recommend several of successful applicants of this program who meet all the criteria specified by the MEXT. Those applicants will be contacted individually with the notification of the second screening result. For further information about this scholarship, please check our website.

### ● MEXT Honors Scholarship for Privately Financed International Students

Applicants who achieve a superior score in the EJU might be eligible to receive an Honors Scholarships for Privately Financed International Students after enrolling in a Japanese university. Those who wish to be considered for the scholarship must indicate their intention in their EJU application. This scholarship is only available for those who reside in Japan with “Student Visa” status. - The university reserves accommodation for all first-year students newly arriving in Japan. The rent will be reasonable, based on current rental prices in Kyoto.
- Comprehensive support by English-speaking staff will be provided to international students to assist them with their living and studying needs in Kyoto.

## **X Admission Policy**

### **Philosophy and Objectives**

The Faculty of Engineering, Kyoto University, emphasizes the building of a solid foundation for learning, under the tradition of a liberal academic environment. A liberal academic environment is one where students are encouraged to view the world free of preconceptions by garnering a scientific eye. This entails the development of a critical attitude toward academia, and becomes a solid foundation for learning. It is widely perceived that the focus of the Faculty of Engineering is largely on applied technologies. However, the Kyoto University approach differs from the general perception and is somewhat unique. In short, the Faculty of Engineering, Kyoto University, adheres to its principle academic approach based on its belief that a deep understanding of the basics is essential for applying technologies to a wide variety of situations in the future.

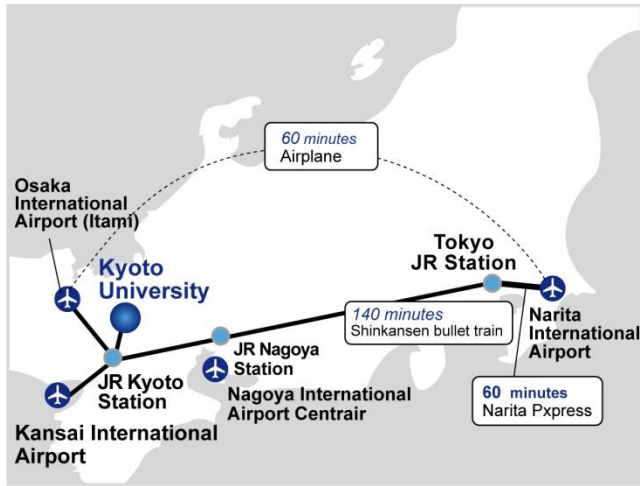

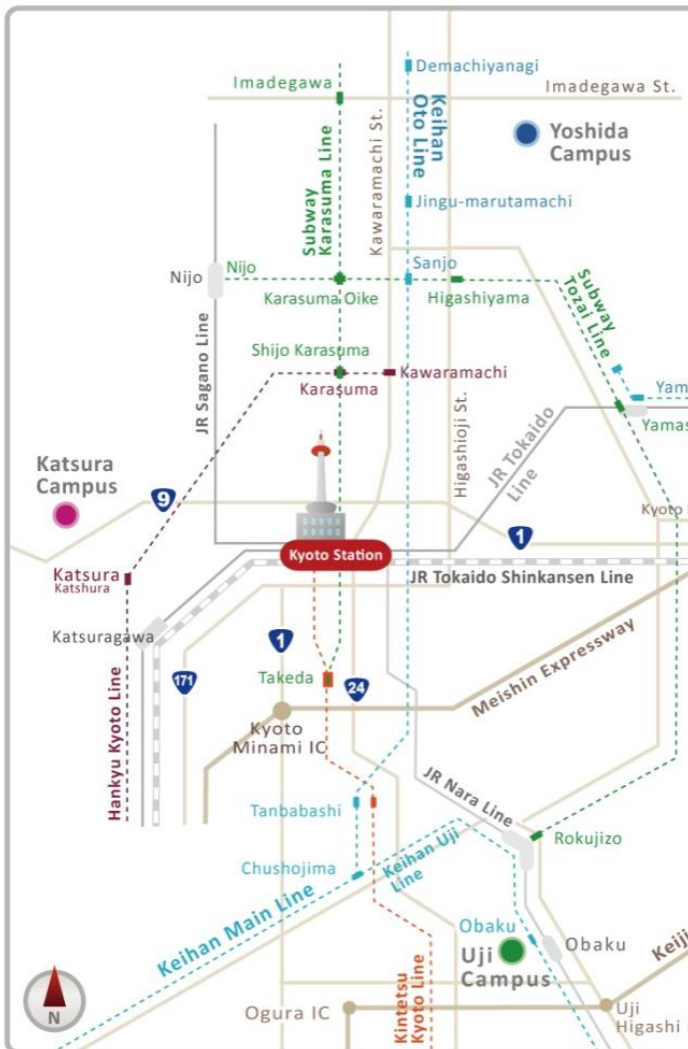
